WE WILL SEND CONFIRMATION OF THE RECEIPT OF YOUR BOOKING FORM AND PAYMENTS BY EMAIL, UNLESS YOU SPECIFICALLY REQUEST IT TO BE SENT BY POST. **YOUR BALANCE PAYMENT WILL BE DUE SIX WEEKS BEFORE THE START OF YOUR HOLIDAY**; ON RECEIPT OF THIS WE WILL SEND FINAL CONFIRMATION AND ARRIVAL DETAILS.

IF THE BALANCE PAYMENT IS NOT RECEIVED BY THE GIVEN DATE, WE RESERVE THE RIGHT TO RE-LET THE ACCOMMODATION AND YOUR DEPOSIT PAYMENT WILL BE FORFEITED.

PLEASE ENSURE YOU HAVE ADEQUATE HOLIDAY INSURANCE. DEPOSITS OF £50 ARE NON-REFUNDABLE INCLUDING FOR THE CURRENT COVID 19 PANDEMIC.

BALANCE REFUNDS WILL ONLY BE GIVEN IF WE ARE ABLE TO RE-LET YOUR HOLIDAY DATES. IF WE ARE ABLE TO RE-LET PART OF YOUR WEEK, REFUND WILL BE MADE ON A PRO-RATA BASIS. BALANCE REFUNDS WILL BE SUBJECT TO A £20 ADMINISTRATION FEE.

OCCUPANCY OF THE ACCOMMODATION IS RESTRICTED TO THE MAXIMUM NUMBER PERMITTED AS STATED IN THE CHALET DESCRIPTION; ALSO TO THOSE NAMED ON THE BOOKING FORM UNLESS OTHERWISE NOTIFIED IN ADVANCE OF ARRIVAL.

WE AIM TO PROVIDE CLEAN, COMFORTABLE, WELL-EQUIPPED CHALETS FOR OUR GUESTS TO ENJOY A RESTFUL AND ENJOYABLE HOLIDAY. **ANY FAULTS OR PROBLEMS WITH THE ACCOMMODATION SHOULD BE NOTIFIED TO US AS SOON AS POSSIBLE DURING YOUR STAY** IN ORDER THAT WE CAN INVESTIGATE THE COMPLAINT AND DEAL WITH IT ACCORDINGLY. **WE WILL NOT ACCEPT RESPONSIBILITY FOR ANY PROBLEMS ARISING DURING YOUR STAY NOT NOTIFIED TO US AT THE TIME.**

WE RESERVE THE RIGHT TO ENTER THE CHALET, WITHOUT PRIOR NOTICE IF IT IS NOT POSSIBLE TO OBTAIN, TO DEAL WITH ANY PROBLEMS OR EMERGENCIES. IF WE ARE UNABLE TO PROVIDE ACCOMMODATION AS BOOKED DUE TO CIRCUMSTANCES BEYOND OUR CONTROL, IE FIRE, FLOOD ETC. AND WE ARE UNABLE TO PROVIDE ALTERNATIVE ACCOMMODATION, ALL PAYMENTS RECEIVED WILL BE RETURNED TO YOU IN FULL AND YOU WILL HAVE NO FURTHER CLAIM AGAINST WINTERTON CHALETS OR THE CHALET OWNER.

WINTERTON CHALETS ARE NOT RESPONSIBLE FOR ANY INJURY OR ILLNESS DURING YOUR STAY WITH US.

THE CHALET MAY BE OCCUPIED FROM 2PM ON THE DAY OF ARRIVAL UNLESS OTHERWISE ADVISED. IF THE CHALET IS NOT READY FOR OCCUPATION AT THE STATED TIME DUE TO CIRCUMSTANCES BEYOND OUR CONTROL, THE HIRER WILL HAVE NO CLAIM AGAINST WINTERTON CHALETS OR THE CHALET OWNER. ARRANGEMENTS FOR KEY COLLECTION WILL BE NOTIFIED IN YOUR BALANCE CONFIRMATION LETTER.

THE CHALET MUST BE VACATED BY 10AM ON THE DAY OF DEPARTURE AND LEFT IN THE SAME CLEAN AND TIDY CONDITION AS FOUND ON ARRIVAL. THE HIRER WILL BE RESPONSIBLE TO MAKE GOOD OR PAY FOR ANY DAMAGE TO THE ACCOMMODATION, FURNISHINGS AND FITTINGS, AND ALL CONTENTS.

FOR HEALTH AND SAFETY, AND THE BENEFIT OF OTHERS, **SMOKING IS NOT PERMITTED INSIDE THE CHALET.**

AMPLE CAR PARKING IS PROVIDED - **UNDER NO CIRCUMSTANCES ARE VEHICLES TO BE DRIVEN OR PARKED ON THE GRASSED AREAS OF THE SITE.**

DOGS ARE WELCOME, ON THE UNDERSTANDING THEY WILL NOT BE ALLOWED TO DAMAGE OR SOIL THE CHALET FURNISHINGS. PLEASE BRING THROWS TO COVER THE SEATING, PARTICULARLY IF THEY ARE MOULTING! FOR THE SAKE OF OTHER GUESTS DOGS MUST NOT BE ALLOWED ON THE BEDS. ANY DAMAGE SHOULD BE RECTIFIED OR PAID FOR.

PETS MUST NOT BE LEFT UNATTENDED IN THE CHALET AT ANY TIME AND YOU MUST OBEY SITE RULES REGARDING DOGS i.e. DOGS MUST BE UNDER CONTROL AT ALL TIMES AND NOT PERMITTED TO RUN UNSUPERVISED - ALL 'ACCIDENTS' MUST BE CLEARED UP AND THE PLASTIC BAGS USED SHOULD BE PUT IN THE BINS PROVIDED.
